



30% RESIDENTIAL ENERGY EFFICIENT PROPERTY FEDERAL TAX CREDIT

Section 25D of the Internal Revenue Code provides a 30% tax credit to individuals for "qualified solar electric property expenditures" made by the taxpayer during taxable years beginning after December 31, 2008. Qualified solar electric property expenditures are expenditures for property which uses solar energy to generate electricity for use in the taxpayer's residence. Taxpayer's are permitted to rely on a manufacturer's certification in determining whether property is eligible for the credit. Taxpayer's are not required to attach the certification statement to its tax return on which the credit is claimed, but should keep a copy for its records.

Below is the Certification by GTO Access Systems, LLC that the products listed are eligible for the Residential Energy Efficient Property Tax Credit.
